#### Sub: Transfer of Equity Shares of the Company held by you to the Investor Education and Protection Fund (IEPF) Account.

We wish to inform you that as per the applicable provisions of the Companies Act, 2013 (Act) all unpaid/unclaimed dividends are required to be transferred by the Company to the Investor Education & Protection Fund (IEPF) established by the Central Government after completion of seven years.
